	REVIEW SCALIA LAW'S TECHNOLOGY REQUIREMENTS
	Scalia Law School has a mandatory laptop requirement for all incoming students. Verify that your laptop meets the school's technology requirements. More information can be found on the Computing Information for Incoming Students page.
	SEND YOUR FINAL TRANSCRIPTS TO SCALIA LAW SCHOOL (IF APPLICABLE)
	If you graduated in spring or summer 2026, ask your undergraduate institute to submit your final transcript to Scalia Law School's lawapps@gmu.edu .
	NOTIFY THE ADMISSIONS OFFICE OF NEW CHARACTER AND FITNESS ISSUES
	Continue to notify must the Admissions Office of any new character and fitness issues. Refer to the character and fitness section of your application.
	ORDER YOUR PARKING PASS (IF APPLICABLE)
	If you plan to park on campus, you must pay for a parking permit. Parking permits for 2026-2027 will be available for purchase at parking.gmu.edu starting July 27 at 8 am. Parking permits are sold on a semester basis. Semester and daily/weekly/monthly parking permit rates are posted on the Parking and Transportation website .
